Hi Mario and Marianne!

We hope that you have been enjoying your summer and that start up has gone smoothly for you! It's hard to believe that there will be learners back in our buildings on Tuesday!

At our AGM scheduled for September 26 in Toronto, we are going to propose several changes to our By-laws.

The first attachment is what we **were** going to propose at the AGM on September 26, 2024.

The second attachment is the exact same document....without the phrasing, "Indigenous Institutes"

After a couple of meetings facilitated by CESBA in June (after the Board retreat), Paul met with Vice Chair Andrea and I and proposed an amendment to our planned By-law revisions for the AGM.

The proposal would be to remove any wording referencing *Indigenous Institutes* from the proposed revise By-laws; the Global Ends; and the one-page draft Strategic Plan that we discussed in June.

Only the actual revised By-laws need a motion to do this as we agreed on the revisions at our June Board meeting.

All three of us unanimously agreed that we should bring this forward to the rest of the 2023 – 2024 CESBA Board (the two of you) before our AGM. We agreed that in hindsight and retrospect, and given the recent June meetings hosted by CESBA, this should not be a specifically stated focus for CESBA moving forward. We also believe that it will not change in any way the current CESBA practice of support for Indigenous learning institutes based on capacity and availability.

The motion reads:

"Motion to approve the removal of the terminology 'Indigenous Institutes' from revised By-law section 1.01 h) and 8.01."

If the motion is approved by the two of you, then Paul will inform Urzula to include this in the Minutes as a revision.

Paul checked with Governance Coach Heather Terrence and this is a perfectly acceptable Board process with tight timelines.

The revised By-laws that we present to the membership at the AGM will be the second attachment (with the affected wording removed).

Please feel free to reach out to any of us if you wish to discuss this motion in more detail before either approving or voting against! We can of course set up a Teams meeting to discuss this in more detail if you either of you wish.
